INSTRUCTIONS FOR AUTHORS OF PROCEEDINGS

The Proceedings of all papers submitted before August 30 will be published on a CD-ROM. Articles submitted after this date will not be accepted. There is no maximum or minimum length for the articles, however we recommend not to exceed 50 000 characters. We recommend subdividing the text into paragraphs with subtitles. As English language editing will not be provided, authors for whom English is a second language may choose to have their manuscript professionally edited before submission to improve the English.

1. The electronic version of your contribution (.doc, .docx or .rtf format) should be sent to exile2011@email.cz as an attached file. Please use Times New Roman fonts (character size 12). The heading of the article should contain the title and the name (s) of author (s).

2. Notes and references

We encourage the authors to use footnotes for additional and complementary information and explanations.

The references and other bibliographic information must be given in the form of footnotes.

References to books include author's full name, complete title of the book in italics, place of publication and publisher's name, date of publication, page numbers. Example:

Joseph Needham, *Science and Civilisation in China*, Vol. 1 (Cambridge: Cambridge Univ. Press, 1954), p. 7.

References to articles in periodicals include author's full name, title of article (in quotes), title of periodical in italics, year, volume number, number of issue if pagination requires it, page numbers of article, number of particular page quoted.

Example:

John C. Greene, "Reflections on the Progress of Darwin Studies", *Journal of the History of Biology*, 1975, 8:243-273, p. 270.

References to articles in edited volumes include author's full name, title of article (in quotes), editor/s' name/s, title of the edited volume in italics, page numbers of article, number of the particular page quoted.

Example:

Margaret W. Rossiter, "American Scientific Societies and the Equal Rights Amendment, 1977-1982", in: Štrbáňová, S. – Stamhuis, I. - Mojsejová, K. (eds.), *Women Scholars and Institutions* (Prague: Výzkumné centrum pro dějiny vědy, 2004), p. 101-114.

Succeeding references use an abbreviated version of the title with the author's last name. Example:

Greene, "Reflections," p. 250.

When referring to websites try to use as simple a method as possible avoiding the inclusion of lengthy addresses for individual web pages especially when these are likely to change by the time.

3. Tables and pictures

Tables and pictures should be numbered and contain comprehensible captions and explanations. They are submitted in electronic form inserted directly into the correct place in the article.

4. Unusual alphabets, special characters, mathematical and chemical formulas should be clearly marked; the letters must include all diacritical marks.
